

# Your supplementary Notice of Valuation

The Valuer General sends you a Notice of Valuation showing your land value when your council receives new values for rating. This happens at least every three years.

The Valuer General sends you a supplementary notice if we:

- change your land value through our quality assurance program
- change your land value to reflect changes to the zoning or features of the land
- change the property description, area or dimensions on your notice
- make new valuations for land in a subdivision
- make a single new valuation for land that was previously valued separately
- make separate new valuations for land that was previously valued together.

You can find the reason the Valuer General has sent you a supplementary notice on the front of your notice.

## Property information on your Notice of Valuation

The ownership details, property description, area and dimensions on your notice are taken from the NSW land titles system.

The zoning on your notice is taken from your council's environmental planning instrument.

Please contact us if you have any concerns about the property information on your notice.

## Who uses land values?

### Councils

Land values are one factor councils use to set rates.

We will tell your council if we change your land value. They will adjust your rates if they need to.

Please contact your council if you have any questions about your rates.

### Revenue NSW

Revenue NSW uses land values to calculate land tax.

We will tell Revenue NSW if we change your land value. They will adjust your land tax if they need to.

## Concerned about your land value or property information?

If you think the land value or property information on your notice is wrong you can lodge an objection with the Valuer General to have it reviewed.


You have 60 days to lodge an objection. The last date to do this is printed on the front of your notice.
